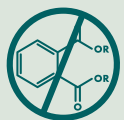
RECYCLED CONTENT: United Fabrics offers a rapidly expanding portfolio of products containing partial- or fully-recycled content.



PFAS FREE: All of United Fabrics products have always been or are now available in PFAS-free constructions. While some of our inventory is currently in transition to PFAS-free, any fabric can be obtained in a PFAS-free construction per request.



PVC FREE: United Fabrics offers Writer's Block polyurethane products which are ink-resistant and PVC free. PVC free materials do not contain or emit harmful chemicals such as plasticizers, phthalates, and isocyanate and do not release toxic fumes when burned or pollute the soil and water when disposed.



PHTHALATE FREE: Phthalates are a group of chemicals used to make plastics more flexible, pliable, and less prone to breaking. They are also referred to as plasticizers. United Fabrics offers 300+ faux leather selections in a phthalate-free construction.



REACH

REACH (Registration Evaluation and Authorization of Chemical Substances EU): European Union regulation that limits the use of and requires labeling for a multitude of chemicals. Four phthalates are listed amongst the "Substances of very high concern" (BBP, DBP, DEHP, DIBP) in addition to about 50 other chemicals. United Fabrics offers 520+ selections that meet REACH Compliance, including all of our Crypton Leathers.



GREENGUARD GOLD CERTIFIED: Certification for low chemical emissions, contributing to healthy indoor air quality. All of the following products in our line are GREENGUARD Gold Certified:
